- o Under 'Select county(s)', click on '043, DUPAGE'
- o Under 'Select indicator', click on the indicator(s) of interest
- Under 'Aggregate multiple counties', click 'No' if you need only DuPage County data
- o Under 'Select data years', click on the year. To select multiple years, hold down the shift key and select the years.
- o Under 'Choose to report by race or ethnicity', race reports as 'White', 'Black', and Other'. Ethnicity reports as 'Hispanic' and 'Non-Hispanic'.
- o Click 'Search' and the report will open in a new screen.
- o NOTE: After an initial report has been run, user must click on the browser screen to see subsequent reports. Reports will not pop-up.
